- 5. The Bid process will be conducted through a TWO-envelope system. Interested Bidders are requested to submit their Technical Bid separately from their Financial Bid containing price information. Specific instructions for the submission can be found Section I Instructions to Bidders, clause 22 Submission, Sealing and Marking of Bids.
- 6. Bidders submitting bids by hands shall enclose the Technical Proposal and the Financial Proposal of the bid in separate sealed envelopes duly marked as "Technical Proposal" and Financial Proposal". Both these envelops (Technical Proposal and Financial Proposal) shall be enclosed in one single envelop to the address indicated in Para 3 and shall be deposited in the tender box placed at the , 2nd Floor, "Savsiripaya", 123, Wijerama Mawatha, Colombo 07 Sri Lanka, on or before 14.30 hrs at 21.11.2024 The Name of the Contract and the RFP Number shall be stated on top left-hand corner of the envelope of the bid.
