CONSTRUCTION INDUSTRY DEVELOPMENT ACT, No. 33 OF 2014

RULES made by the Construction Industry Development Authority under section 57 of the Construction Industry Development Act, No.33 of 2014 read with section 44 of the aforesaid Act.

Rules

1. These rules may be cited as the Construction Industry Development (Registration of Heavy Construction Machinery and Equipment) Rules of 2019.
2. An owner of a heavy construction machinery and equipment specified in the First Schedule hereto, shall not use such heavy construction machinery and equipment unless such heavy construction machinery and equipment are registered with the Construction Industry Development Authority (hereinafter referred to as the “Authority”).
3. (1) Every application for a Certificate of Registration under rule 2 shall be made to the Director-General of the Authority in a form as may be determined by the Authority accompanied by a fee specified in the Second Schedule hereto.



(2) Every application under sub-rule (1) of rule 3 shall be accompanied with the following documents :-

- (a) the Certificate of Registration issued by the Commissioner General of Motor Traffic and the copy of the valid Revenue License for the road running machinery ;
- (b) an affidavit from the owner specifying the ownership of the machinery or equipment and any other documents to prove the ownership ; and
- (c) status report of the machinery and equipment relating to the serviceability issued within a period of six months from the date of application by a Mechanical Engineer who is graduated from a university recognized by the University Grants Commission of Sri Lanka in the field of Mechanical Engineering.

(3) An application under this rule shall contain the details of the heavy construction machinery and equipment. The Director-General may, where necessary require an applicant to furnish further information.

4. Upon the receipt of an application under rule 3, the Director-General shall, on the consideration of the matters contained in the application and documents, either to register such machinery or equipment and issue a Certificate of Registration or for the reasons to be recorded by him refuse to register such machinery or equipment. The Director-General shall in writing inform the applicant of his decision and in a case of a refusal to register such machinery or equipment, he shall state his reasons therefor.

5. Every Certificate of Registration shall be in a form as may be determined by the Authority and such Certificate of Registration shall, unless revoked earlier, be valid for a period specified therein and shall be subject to such terms and conditions specified therein.

6. The Director-General may revoke a Certificate of Registration issued under rule 4, if he is satisfied that the owner of machinery or equipment to whom the Certificate of Registration has been issued has violated any provisions of the Construction Industry Development Act, No. 33 of 2014 or regulations or rules made thereunder or any of the terms and conditions of the Certificate of Registration.

7. (1) A Certificate of Registration issued under rule 4 shall be renewable on application being made in that behalf to the Director-General not less than thirty days before the expiry of the Certificate of Registration and be accompanied by a fee specified in the Second Schedule hereto.

(2) A Certificate of Registration shall be renewed by the Director-General, only if he is satisfied that the owner of machinery or equipment to whom the Certificate of Registration has been issued has complied with the provisions of the Construction Industry Development Act, No. 33 of 2014 or regulations or rules made thereunder or any of the terms and conditions of the Certificate of Registration.

8. Every person who is aggrieved by the decision of the Director-General may make an appeal to the Appeals Board established under the provisions of section 53 of the Construction Industry Development Act, No. 33 of 2014.

9. The Director-General shall cause -

- (a) to maintain a register in which every heavy construction machinery and equipment registered with the Authority under these rules shall be entered in a format set out in the Third Schedule hereto ; and
- (b) to update regularly and be accessible to the general public.

Reigstration Fee and Renewal Fee for Heavy Construction Machinery and Equipment

For the First 25 machineries	Rs. 1000/- per each machinery
From the 26 machine to 50 machine	Rs. 750/- per each machinery
From the 51 machine to 75 machine	Rs. 500/- per each machinery
From the 76 machine to 100 machine	Rs. 300/- per each machinery
From the 101 machine to higher	Rs. 100/- per each machinery

Above fees are excluding applicable taxes.
