**THE CONSTRUCTION INDUSTRY DEVELOPMENT ACT, No. 33 OF 2014**

RULES made by the Construction Industry Development Authority under Section 57 of the Construction Industry Development Act, No. 33 of 2014, read with Section 40 of the aforesaid Act.

**Rules**

1. These Rules may be cited as the Construction Industry Development (Monitoring System of Contractors) Rules of 2020.
- 2 There shall be a Monitoring System for the monitoring of contractors registered under the Construction Industry Development Act, No. 33 of 2014.
3. Every contractor registered under the said Act shall comply with the Monitoring System of the Construction Industry Development Authority established under rule 2, which shall be maintained as a physical, manual or web based Monitoring System.
4. Every contractor registered under the said Act shall facilitate the officers of the Construction Industry Development Authority to physically monitor their activities by visiting the sites during day time.



5. Every contractor registered under the said Act, every consultant or engineer, as the case may be, of a contract and the relevant employer shall be entitled to access the web based Monitoring System of the Construction Industry Development Authority.

6. The Monitoring System shall use all inputs, views, feedback of all parties to a contract, including the employer, the consultant, the engineer or the contractor. Such inputs, views, feedback shall be collected through the manual, physical and web based monitoring system of the Construction Industry Development Authority.

7. The performance of a contractor shall be evaluated annually, on the basis of -

- (a) quality of work ;
- (b) time taken to complete the project ; and
- (c) cost management.

for the purpose of arriving at a rating for a contractor.

### **Rules**

1. These Rules may be cited as the Construction Industry Development (Power to Instruct and Request Information) Rules of 2020.

2. The Construction Industry Development Authority (hereinafter in these rules referred to as the “Authority”) shall require a local authority or a statutory body to provide information on quarterly basis on-

- (a) project for which approval for permit or licence have been sought ;
- (b) on-going projects ; and
- (c) completed projects.

3. Every such construction project referred to in rule 2 shall be categorized under the following sectors :-

- (a) buildings ;
- (b) water supply and sewerage ;
- (c) highways ;
- (d) bridges ;

- (e) irrigation and drainages canals ;
- (f) dredging and reclamation ;
- (g) storm water disposal and land drainage ;
- (h) maritime construction ; and
- (i) heavy construction in a specified area.

4. Details of each project under each category of projects referred to in rule 3 shall be in a form as may be determined by the Authority and shall include -

- (a) project name and location of the project ;
- (b) name of the client ;
- (c) sector ;
- (d) project type ;
- (e) capacity or quantity ;
- (f) project cost ;
- (g) funding institute or agency ;
- (h) funded value ;
- (i) validity period of environmental approvals ;
- (j) date on which permit or licence has been granted ;
- (k) date of commencement/expected date of commencement ; and
- (l) date of completion or expected date of completion of the project.
